4. The carrier makes no warranty of any nature except those required by law. Liability for any warranty that cannot be excluded shall be limited to the cost of re-supplying services.
5. The contents of this document shall be a complete bar to any action arising out of participation in the activity against the carrier.
6. This document shall be governed by the laws of the state or territory where the activity takes place.
